IMPORTANT NOTE:
Because Arbor Trace Condominium Association, Inc. is intended to provide "housing for older persons" as a "55 and over community" under applicable statutes and administrative rules, it is required that a copy of a valid photo ID showing proof of age be attached to this application for each person who will be an owner or an occupant of the unit. Common acceptable proof of age documents include a current driver's license or a current passport provided they contain specific information about current age or date of birth. As a "55 and over" community, no unit may be occupied by anyone unless there is at least one person simultaneously occupying the unit who is 55 years of age and over. Occupancy by a person under 21 years of age is only permitted on a temporary basis, as provided in Section 14.3 of the Declaration of Condominium.
