## EXHIBIT A - SERVICE CENTER FEES

## SERVICE CENTER BASE FEE: <br> \$1,350.00 PER MONTH FOR SINGLE MEMBER \$350.00 ADDITIONAL PER MONTH FOR EACH ADDITIONAL MEMBER <br> THE FOLLOWING SERVICES ARE PROVIDED IN THE BASE FEE:

(1) SERVICE CENTER PRIVILEGES WITH ACCESS TO ALL OF THE FACILITIES.
(2) HEALTH AND WELLNESS SERVICES

Services include blood pressure and vital signs check at Arbor Glen. Arbor Glen staff will monitor and respond to health emergency calls 24 hours a day, render first aid as needed and summon ambulance and/or physicians as required. Staff will assist in arranging and coordinating third party medical services in Member's Condominium Unit, if requested. The fees will be determined by Member and third-party service provider.
(3) SOCIAL AND RECREATIONAL SERVICES

Social and recreational services, events and excursions will be coordinated by our Activities Director.
(4) TRANSPORTATION SERVICES

Services include scheduled trips for shopping, cultural, recreational, and social activities. Transportation will be provided daily within the community between Condominium Units and the Service Center for dining. With 24 -hour advance notice, transportation will be provided to medical/dental appointments on Tuesday, Wednesday, and Thursday of each week. Staff will also assist in arranging for emergency transportation, as needed.

## CAPITAL RESERVE FEE: \$50.00 PER MONTH

This fee goes into a segregated account to be used for capital replacements and deferred maintenance on the Service Center and pool facilities.
